FYI - You are not able to have a Protection Dog 1-3, without offering either Tracking, or Obedience in conjunction with the Protection Dog 1-3.

**FYI – Please do not apply for 2 one day trials unless you are going to have a full trial on your first day. (It is now 36 parts per day.) If you really think you might have more than 36 parts in one day then please book one 2 day trial, then if it looks like you need a second day you are already approved for that second day. That saves cancelling a trial which is extra paperwork for everyone. Remember the judges are volunteering their time, and they would prefer to judge one full day then 2 half day trials.**
